



Richard Lutz, president of Lawrence and Dykes Architects, sees numerous benefits to the school district: "This project will provide complete system renovations, including new heating, air conditioning, electrical systems and technology. Both the elementary and middle schools must be LEED (Leadership Energy Efficient Design) Silver Certified, requiring that the energy usage of the building must be brought to a certain level. For example, the buildings will have new energy-efficient windows as well as measures that incorporate daylight in order to reduce the use of electrical lights."

Phase Two of the Renovation and Construction Underway

The clock has begun ticking on phase two of the renovation and building program. Phase one of the building program used local shared monies of \$24 million, passed in a bond issue in 2002, to build Northwest Elementary and Northwest High School. Phase two will provide approximately \$29 million in state monies that will provide renovations and additions to Stinson Elementary/Intermediate School, the middle school and the high school. This phase is presently in the planning stage as the Ohio Schools Facilities Commission permits 26 months for completion of the work.

Lutz stresses the importance of the additions of life-safety systems with new sprinkler systems throughout the building as well as improved security systems: "We will be building secure entries that will direct visitors to the main office and keep unwanted strangers from walking through the building."

Members of the facilities committee include Don Schalmo (local builder), Dave Walker (construction manager), Michael Kramer (energy consultant), Gary Johnson (manager at Carter Lumber) and Jim Gindlesberger (board of education member). This committee is overseeing the entire project. In addition, two parents, Teresa Hinkle and Derek Pullen, serve on the middle school design team.

Kay Stephan's commitment to the Northwest Schools is really no surprise, considering the impact the district has had on her life. Her father, John Kunkle, a graduate of Clinton High School, played an active part in the consolidation of the district and building of the schools in the 1950s. She married her high school sweetheart, Denny Stephan, and their three sons, Sean, Scott and Joel, graduated from Northwest. Kay feels that the schools provided a solid education for her children: "I would be sick if anything happened to Northwest. We need to buck up and do whatever we can. Where else can you find a community like this where you can safely rear your children?"

skills. She has also started her own company, Classic Protocol, which provides etiquette training for businesses, professional organizations and university leadership programs. Kay began her career teaching at Northwest High School in the late 1960s until she became a full-time mom.

For the past 41 years, Kay and seven high school friends from the class of 1964 get together one Monday each month to play cards or Mexican Train Dominoes, share stories and reminisce. Four women are from Clinton—Diane, Evelyn, Denise and Kay. Four are from Canal Fulton—Helen, Sheri, Sandy and Joanne. Most were in the band under the direction of Mr. Puffenberger, and their "superior" rating led to a televised performance in 1963 in Cleveland. Over the years, they have supported each other through weddings, baby showers, graduation parties and funerals. Together they plan their high school reunions every five years. The merging of the school districts in Clinton and Canal Fulton seemed to provide more opportunities for long-lasting friendships; there were no distinctions between the towns.

Kay hasn't been happy with all of the decisions that the district has made over the years, so she has become involved in the community effort to study the finances and practices of the schools. She believes the coffees are helping people obtain direct answers to their questions and stop some of the rumors. She feels that some residents of the community have become mired in "bad blood, bad feelings, misconception, mistrust that we must get past if anything is going to change." She adds, "It's like a divorce. We either have to get over it or give up." Last year, in order to celebrate their fortieth anniversary, Kay's card club of high school friends attended the last show of the Carousel Dinner Theater for the first time, just before it closed permanently. Kay compared the experience to the situation in Northwest, "We take things for granted, thinking that they're going to be around forever. I hope the same thing doesn't happen to Northwest Schools."

NORTHWEST LOCAL SCHOOLS FINANCIAL FACTS

The financial position of the Northwest Local School District is in dire straights. This message has been circulated throughout our community for quite some time and through many different means. However, there are still many questions and much confusion as to the true state of the school district's financial position. Based on guestions I have received and comments that I have heard I would like to share the following facts about Northwest Local School's financial position.

- Northwest Local Schools finished the 2009 school year \$1,124,954.00 in debt.
- Northwest has been placed in Fiscal Caution by the Ohio Department of Education. This means that an individual from the Ohio Department of Education is on site once a month to review and complete an analysis of our revenue and expenditures.
- Fiscal Emergency and state takeover allows us to borrow money to operate our school on a daily basis. All money borrowed must be repaid within the allowed time.
- The amount of money Northwest receives in local real estate tax and state aid annually ranks our district in the bottom 3% of the state for revenue received per student.
- Northwest receives tax dollars for general operating expenses and also for what is called Permanent Improvement needs. Permanent Improvement Funds can only be used for brick and mortar type of expenditures. The bus garage was purchased using dollars from the Permanent Improvement Fund and not the General Operating Fund. The Permanent Improvement Fund is the source of funds used to make the payments on the loan.
- Northwest certified and administrative staffs will not receive a base salary increase for four years under the current contract, and the classified staff will not receive a base increase under their current contract. This action will save the district more than \$1,000,000 during that time.
- Total expenditures for school year 2007 were \$18,605,853, and the budget for the 2010 school year is \$16,952,251. The budget reductions and staff layoffs included in the 2010 budget represent an 8.8 percent decrease in spending.

"Even though our district continues to struggle in a very difficult financial situation, Mr. Levengood continues to be responsible and accountable to our community while also being honest and emphatic about how the proposed budgetary reductions impact students. Such reductions are discussed

to seek input, as a means to democratically determine the best direction to proceed. Mr. Levengood is very approachable and is always willing to meet with staff to discuss any questions about budgetary procedures."

The Northwest Local School District has officially left the NBC. This is just one of the many ramifications of the district cutting back on extracurricular activities. After the levy defeat in May of 2009, the district drafted a withdrawal letter and presented it to the NBC, which voted unanimously to accept it.

The district will field teams through the 2010-2011 school year in order to fulfill its contract commitments with the NBC. Even if additional funding becomes available, it will be difficult for Northwest to rejoin the NBC and will make it increasingly difficult to find teams to compete against.

"This is a sad time for Northwest," said Athletic Director Gary Woods. "After 59 years of competition, the Northwest sports program will cease to exist. And it isn't just sports; all extracurricular activities will end. And the lessons the students learn outside of the classroom will go untaught."
