

Northwest Local Online Learning Option

- The online learning option will be hosted using a digital platform and facilitated by a certified teacher.
- Student will be required to meet the grade level attendance and seat time expectations as outlined for his/her specific grade level.
- Northwest will provide a district owned device for students who elect to participate in the online learning option.
- Families are liable for any damage that occurs to the district owned device and will pay for the repair or replacement to ensure that the student can meet his/her learning goals
- Families are required to secure access to reliable internet and ensure that it is maintained through the period of online learning.
- Grading, assessment and reporting policies are consistent with inperson instruction.
- Families are only able to modify their choices at the end of each nine

Online Learning Information

Curriculum Platforms

- Students will take part in all instruction at home via online learning. This option is different from what students experienced during remote learning last spring.
- Students participating in the online learning option may be required to report to a district building for assessments periodically through the year.
- If state or local regulations require a school closure, students participating in the online learning option will continue as scheduled with the online learning option.
- Families are only able to modify their student learning choice at the end of each nine weeks.
- Students participating in this option will be using an online curriculum designed by an outside company for the basis of instruction.
 - ♦ K-8 will be using Acellus https://www.acellus.com
 - K-3 students will also complete Fundations Lessons through Google Classroom.
 - ♦ 9-12 will be using Florida Virtual https://www.flvs.net
- Students will be assigned to a Northwest Google classroom and receive support from district staff or county consortium teachers who will facilitate and support student learning, create an online classroom community and communicate regularly with families.
- The curriculum will meet the same Ohio Learning standards used by Northwest Local schools, but it will not necessarily match the same pacing or activities that are delivered in school buildings.

- Students will have access to courses in all core areas (English language arts, mathematics, sciences and social studies).
- Students will also have limited access to special area courses (K-5) and elective courses (6-12). Students in grades 6-12 may not have access to their full schedule as planned this past spring.

Participation Requirements

- Students enrolled in an online learning program, along with their parent or guardian, are required to complete a Parent/Student Orientation. This orientation, conducted by an online coordinator or designee, will provide the necessary information to navigate the online learning platform, and to learn the policies and procedures for successful completion of online learning.
- Elementary (K-5) students will be expected to have access to log into their Google Classroom during student hours (8:30 a.m. – 3:00 p.m.). Students will not be online for the entire learning day, students need to be available to engage with their classroom community of learning (Google Meets) to continue growing their social skills, interact with peers, engage with their teacher and take part in small group learning opportunities.
- Secondary (6-12) students will also be expected to login in during student hours (7:30 a.m. - 2:30 p.m.) for live check-ins, as well as, to meet with teachers for teacher support and small group learning opportunities. Students will not be online for the entire learning day.
- Students will have access to school counselors and mental health services, athletics and extra-curriculars, interventions, special education and gifted services.

Student Attendance and Grading

- Students and teachers will participate in virtual check-in meetings designed to support student course progress and provide opportunities for students to connect with the teachers and with each other.
- Grading, assessment and reporting policies are consistent with in-person instruction.
- Students will receive interim progress reports at the mid-point of each nine-week period.
- Students will receive final grades for all classes at the end of each nine-week period. The grades will be entered into the district's student information system and accessible through the eSchool Parent Access Center (PAC).
- Students who take high school level coursework will receive credit for those courses upon meeting all course requirements including required state assessments.
- Student will be required to meet the grade level attendance and seat time expectations as outlined for his/her specific grade level.
 - ♦ Attendance will be taken daily via live sessions, completion of assignments, classroom Google sessions, and small group learning opportunities when appropriate.
 - ♦ Students will be required to participate both in-person and virtual work in order for full attendance to count for those days.
 - Weekly assignments for each course should take approximate 3-5 hours depending on the age and grade level of the students.
 - Students should plan to work on their assignments daily to stay on track with weekly assignments for each course.

Meal Charging Policy

The goal of the Northwest Local Schools Food and Nutrition Department is first and foremost to provide healthy and nutritious meals to our students so they can better function and learn at school. However, there are guidelines in place that must be followed. Therefore, the following policy has been implemented.

Our policy will be as follows at any level:

- Students will not be allowed to charge ala carte items.
- Students must have cash or sufficient account balance to make a purchase.
- Students whose account balance falls below \$5.00 will be verbally notified of their balance at the cash register.
- This same procedure applies to adults.

To make this a success for both home and school, we offer and online program called, "PayForIt" that allows parents/guardians to deposit money into their child's account (at www.northwest.sparcc.org then click on Parent Tab then "PayForIt") that can be managed from home, allowing the parent to check lunch balances. You will need your student's 10 digit student ID number to access the information. This can be obtained through the school's secretary or the cafeteria. You may also send cash or check with your child/student to school to be deposited into their lunch account. One check can be written for all students in the same family. Please list in the memo section, the students name and how much money you would like placed in each account.

The school lunch program also offers free and reduced lunches for those families whose income meets the criteria. Parents/Guardians may apply online at www.northwest.sparcc.org under the Parent Tab. Forms must be completed each school year to qualify. Only one application per family unit needs to be completed. Forms can also be completed any time during the school year should a situation arise where you may need assistance. We also have applications available at the school offices. It is best to fill these forms out, as soon as possible, to make it a smooth transition for your child/student.

We realize there are of course those times when students or parents/guardians forget lunch money. In this case, we will allow students a onetime charge that day with the intention the charge must be paid the following day. The parent/guardian will be contacted by the school to discuss what options are available in order to eliminate the balance due and enable the student to be able to obtain a lunch in the cafeteria. If a satisfactory resolution is not obtained after these efforts, a letter, this charge policy, and an application for Free and Reduced lunch will be sent home.

Thank you for participating in the Northwest Local School lunch program.

PUBLIC RELEASE

Northwest Local School District announced its 2020-2021 program year policy for free and reduced-price meals or free milk for students unable to pay the full price of meals or milk served under the National School Lunch and School Breakfast, After School Care Snack or Special Milk Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested party.

The Federal Income Eligibility Guidelines will be used for determining eligibility. Children from families whose annual income is at or below the Federal Guidelines are eligible for free and reduced-price meals or free milk if the school participates in the Special Milk Program.

Application forms are being distributed to all homes in a letter to parents or guardians. To apply for free and reduced-price benefits, households should fill out the application and return it to the school. Additional copies are available at the principal's office in each school. A complete application is required. Households which currently receive Special Nutrition Assistance Program Benefits (SNAP, formally known as food stamps) or Ohio Works First (OWF) funds for a child must provide the child's name, the SNAP or OWF case number and signature of an adult household member on the application. Households which do not receive SNAP or OWF funds must provide the names of all household members, the last four digits of the Social Security Number of the adult signing the application or state "none" if the adult does not have a Social Security Number, the amount and source of income received by each household member, (state the monthly income) and the signature of an adult household member. If any of this information is missing, the school cannot process the application.

FREE HEALTH CARE

Families with children eligible for school meals may be eligible for FREE health care coverage through Medicaid and/or Ohio's Healthy Start & Healthy Families programs. These programs include coverage for doctor visits, immunizations, physicals, prescriptions, dental, vision, mental health, substance abuse and more. Please call 1-800-324-8680 for more information or to request an application. Information can also be found on the web at http://jfs.ohio.gov/ohp/consumers/familychild.stm. Anyone who has an Ohio Medicaid card is already receiving these services.

The information provided on the application is confidential and will be used only for the purpose of determining eligibility and may be verified at any time during the school year by school or other program official. To discourage the possibility of misrepresentation, the application forms contain a statement above the space for signature certifying that all information furnished is true and correct. Applications are being made in connection with the receipt of federal funds. Schools or other officials may check the information on the application at any time during the school year. Deliberate misrepresentation of information may subject the applicant to prosecution under applicable state and federal laws.

Households will be notified of the approval or denial of benefits.

Foster children are categorically eligible for free meal benefits regardless of the household's income. If a family has foster children living with them and wishes to apply for such meals or milk for them, contact the school for more information. Under the provision of the policy, Dan Levengood, Treasurer, will review applications and determine eligibility. If a parent or guardian disagrees with the decision on the application or the result of verification, the decision may be discussed with the determining official on an informal basis. If a formal appeal is desired, the household has the right to a fair hearing. A fair hearing can be requested either orally or in writing: Dennis Lambes Superintendent, 2309 Locust St. S, Canal Fulton, Ohio 44614, 330.854.2291. The policy contains an outline of the hearing procedure.

Households may apply for benefits any time during the school year. If a household is not currently eligible and if the household size increases or income decreases because of unemployment or other reasons, the family should contact the school to file a new application. Such changes may make the children of the family eligible for free or reduced-price benefits if the family income falls at or below the levels shown above.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.

As we prepare for the 2020-2021 school year, please note the following guidelines:


- · Mailers with your student's bussing information will go out approximately the second week of August.

Child Find

In an effort to serve young people with disabilities, Northwest Local is continually in the process of locating and evaluating children from 3 to 21 years of age who are suspected as having a disability. Disabilities may include developmental delays, health impairments, autism, and traumatic brain injury. Individuals may contact the building Principals or Director of Special Services about children suspected as having a disability that may qualify for special education services. Information is available about special education policies and procedures in each building by contacting the building Principal. Northwest has a child identification process that includes the location, identification and evaluation of a child suspected of having a disability within and outside

of district buildings. The Department of Special Services coordinates the child identification process. The Northwest evaluation staff uses a variety of community resources and systematic activities in order to identify children requiring special services. Included in this effort is consultation with appropriate representatives of private school students attending private schools located within the boundaries of the Northwest Local District to carry out this process. Northwest ensures that this process for students attending private or religious schools located in the Northwest Local District is comparable to activities undertaken for students with disabilities served in the public school setting.
