School District Income Tax

On May 4, the residents of the Northwest Local School District approved a 1% earned income tax. As we approach the Jan. 1 start date of the income tax, it is important for everyone to get a better understanding of how the tax works.

A school district income tax is collected in the same manner as the state income tax: through payroll deduction, individual quarterly estimated payments and the filing of an annual school district income tax return. Employers will be notified in December by the Ohio Department of Taxation regarding school districts that have passed a new income tax issue and the employers' obligation to withhold the tax. Employers must ask employees as to which school district they reside, but since employees are responsible for the tax it is recommended that they confirm the tax withholding.

Individuals who are self-employed are required to make guarterly estimated tax payments directly to the Ohio Department of Taxation. The Department of Taxation requires individuals to make estimated tax payments if the amount that they will owe with the tax return is greater than \$500.00. Individuals who reside in the Northwest district will automatically be mailed a school district return if they filed a state income return as a resident of Northwest Local the prior year. Generally, all school district income tax returns must be filed and all payments made by April 15.

Your Plan. Your Vote: Next Steps

The Northwest Local School District worked with community members to develop a plan to save the district. The first step was to develop this plan based upon the community desires; the second was to pass a 1% earned income tax accompanied by an additional \$1.1 million in reductions. The last and final step is to renew the original 1992 emergency levy. This 1992 levy is targeted to be on the ballot in May for your vote to continue the revenue. **This is not a new tax.** It is the continuation of an existing tax.

This strategy was endorsed by the Independent Finance Committee.

We will be asking for your input before we place any issue on the ballot. We must be diligent in protecting Northwest's financial situation. It is indeed fragile, and the district cannot endure extensive revenue losses from either state or local sources. Let's continue the dialogue.

High Street/Erie Avenue to Close October 11

The High Street/Erie Avenue Plum Creek Culvert replacement was initially slated to take place during the summer so it would have a minimal effect on the school year. A Community Development Block Grant from HUD, however, changed the timeline because funds from this grant were not available until August. The city was required by the grant's guidelines to allow the Stark County Regional Planning Commission to bid the project and hire a contractor, which could not take place until the funds are available. The funds must be spent by the following spring, thus negating the chance the project could be completed in the summer.

The contract has been awarded to Wenger Excavating. The project began work on October 11, and the contract calls for a 240 day work schedule. The contract will require that Erie Avenue/High Street be closed no longer than 90 days, and officials pointed out that the closure may occur in two different stages. The project will call for the replacement of culverts and the installation of drain pipe. In addition, portions of the road will be raised 3 feet above flood stage. The final stage of the project will involve the paving of High Street. The price of the project is \$366,000, which will primarily be paid for through state and federal funds. By postponing the project until this fall in order to obtain government funding, the cost to the city of Canal Fulton is only \$4,000.

This project will address a severe flooding problem. According to Canal Fulton City Manager Mark Cozy, "Most of us who live in the Canal Fulton area and especially those of us with children at Northwest Local Schools have had to deal with the Plum Creek and/or the Tuscarawas River flooding High Street and the road being closed. Exacerbating the problem is that other local streets that can be used such as Lever, Warwick and Clinton will also flood. This flooding seriously impacts fire, EMS, and police response and adds 13 to 14 minutes to response times. The flooding is so chronic, Northwest Local Schools have developed school delay procedures for times when High Street floods. In 2007 there were more school delays attributed to the flooding than there were from ice, snow and fog."

The closure will result in an adjustment in bus times for students at Stinson Elementary and Northwest Middle School. Letters and e-mails detailing the changes were sent to parents. For these details, please go to www.northwest.sparcc.org.

Northwest-Canal Fulton Safe Routes to School Project and Town Hall Meeting

Federal funds have been made available through the Ohio Department of Transportation to create a Safe Routes to Schools Program. The purpose of the Safe Routes to Schools Program is to encourage more K-8 students to walk or ride bicycles to school. Sidewalks, bike paths, street lights, cross walks, etc. can be constructed as well as crossing-guard training and student education programs can be funded through a Safe Routes to Schools Grant. No local tax dollars are required for these fully funded federal grants. students who ride bikes or walk safely to school. There is a need in the community to improve safe options so that parents, city and school officials are confident in encouraging students to walk and/or bike to school. Having more students walk or bike to school will decrease the automobile

The City of Canal Fulton and Northwest Local School District are beginning the process to gather the required information to submit a Canal Fulton - Northwest School Travel Plan in July 2011. A completed School Travel Plan is required to apply for program funding.

The City and School District are working together towards the goal of increasing the number of

congestion at the schools which will improve safety and decrease air pollution, as well as develop healthy exercise habits in students.

The School Travel Plan Team needs input this fall from community members, parents, students and school officials to assist with assessing the needs and developing the details of the plan. There will be a Town Hall Meeting about the project Wednesday, October 27, 2010 at 7 p.m. in the NW Middle School Library. 

Credit Flexibility/Educational Options

The Northwest Local Schools, in accordance with Ohio Revised Code 3313.603, have created a Credit Flexibility/Educational Options Plan. This plan affords the students at Northwest High School the opportunity to earn credits towards graduation which are not solely dependent on the traditional model of earning credits as defined by a Carnegie Unit (largely based on time in the classroom). In addition to Credit Flexibility Options, students will have other educational options which allow them to earn credits toward graduation in non-traditional ways.

School administration in the following academic areas: English 9, English 10, Algebra I, Geometry, Social Studies 9 and Social Studies 10.

There is an additional fee of \$80 associated with this opportunity. To be considered, a student must submit a completed application, which is available from a guidance counselor, and full payment by Oct. 1. The administration of the assessments and project will be arranged through the Guidance Department.

Credit Flexibility Options:

Northwest High School will offer several options for students who are interested in earning credit toward graduation.

1. Test-out options: Students will have the opportunity to complete a combination of summative assessment(s) and a research or cumulative project determined by Northwest High 2. Summer school classes conducted at another accredited high school.

Students may earn credit toward graduation by enrolling and successfully completing a course at another accredited high school. It is important that the student complete the application and be pre-approved to assure that the course is required and credit will transfer to Northwest High School. Students are responsible for associated costs. If the class is offered at Northwest High School, the student must take the class here.

Enrollment Decline

The student enrollment at Northwest is showing a serious decline over the last five years. The problem is apparent in the fact that the number of students enrolling in kindergarten is not keeping pace with the number of seniors that are graduating.

In addition to this loss of 252 students through declining kindergarten enrollment, the district has experienced an additional loss of 150 students who have moved from the district or enrolled in another district through open enrollment.

Strategic Planning Session Scheduled for December

On December 2, 3 and 4, Northwest Local School District will convene a group of educators and community members to discuss the district's blueprint for change, planning a common purpose and mission for the next five years. Superintendent Bill Stetler calls the session an act of "aspiration, not desperation." The group will work together to

develop a plan for improvement that is studentfocused and data-based, and the community will be offered an opportunity to offer their suggestions on January 10 at an open meeting. The strategic planning team's results will be presented to community members for their approval on January 24.

Northwest Going Green

In a desire to conserve energy, Northwest has accepted the challenge to step up and become responsible participants in the effort to live efficiently and save resources. A recently completed energy audit showed that several areas in the school district held great potential for reducing energy consumption. The energy savings would be achieved through measures taken at the high school, elementary, bus garage and annex. The expected savings are approximately \$118,500 per year, made possible through the reduction of utility costs and operational costs. A portion of the savings would be used to pay off the debt incurred to fund the project, and the loans are through a government program established through the federal stimulus program that has an effective interest rate of .14%.

The energy audit identified the many of areas where savings can be achieved. Here are a few:

Lighting retrofit - by changing existing lamps and ballasts to new T8 technology, a savings will be generated both in energy and the life of the product. The lighting retrofit project will not only improve lighting levels but also eliminate the need for future recycling costs.

- Parking lot LED conversion LED fixtures emit a high quality white light and allows for the use of less light that is more evenly distributed across an area.
- Classroom occupancy sensors will turn off the lights and set back HVAC systems when a room has been unoccupied for a specific period of time.
- Thin client computing will consolidate the district's computing to a centralized server while leaving the individual work stations, thus reducing operational and repair costs and electric consumption.

Overall, implementing the energy conservation measures will result in improved flexibility of building space, building protection, energy savings, lighting quality, building system communication and operation, and comfort.
